2019 PRIORITY PERSONAL DAYS

Personal Priority Days (PPD)/ Demand are a part of each occupational employee's contractually allotted personal time.

• PPD/demand entitlements will be as follows:

- At least 6 months T.O.E. on 1/1/2019: Entitled to 8 Personal Days Paid (PDP) and 2 Personal Days Not Paid (PDN), of which 8 days (64 hours) can be used as PPD/demand time.
- Employees hired in 2018 with less than 6 months T.O.E. on 1/1/2019: Entitled to 4 PDPs for the year. Four of these days (32 hours) may be taken as PPD/demand.
- Employees hired during any given quarter of 2019: Entitled to 1 PDP day (8 hours) per quarter, including the quarter in which they were hired. Employees will not be entitled to the 8 hrs of PDP until they have worked any portion of the quarter. Once the employee has earned their PDP for the quarter they can use it as PPD/Demand
- · As outlined in the Contract PDP can be prescheduled or taken as PPD/demand.
- Priority Personal Days/Demand Days may be taken for all hours of the scheduled tour or in one (1) hour increments. When partial slots are requested (hour increments default to 8 hours) the RAS team will allow the remainder of the hours to be scheduled, however, the hours within the slot may not overlap.
- Internal transfers to this workgroup: Demand time taken from employee's previous workgroup in 2019 will count towards the 8 days allowed for this calendar year
- Data Specialists and New Hire Training Classes are not covered by this policy. These other groups of employees will be covered by their own Priority Personal Day/Demand policy.
- Contract Section 11.29 "Personal days taken as priority personal days shall be taken during the calendar year earned." (no PPD/demand time carry over)
- Only Personal Day (paid and unpaid) time can be used for PPD/demand time. No vacation time may be used as PPD/Demand.
- As outlined in the Contract, PPD/Demand must be requested <u>prior to the start of the tour</u>. Urgent same day requests made after the start of an individual's tour may be granted based on the needs of the business and are not to exceed the available PPD/Demand slots for the day.
- Requests are taken on a "first call" basis by phone to the designated number only no earlier than 60 minutes prior to the opening of the Center. The number to call is 844-351-7635.
- Either party has the option to reopen negotiations during the life of the current agreement.
 If no agreement is reached, this current agreement will remain in effect.
- This agreement is in effect from January 1, 2019 through December 31, 2019.

2019 PRIORITY PERSONAL DAYS (Continued)

• The PPD/demand caps are in place on a daily basis and are based on the monthly center headcount, excluding Initial Training Classes.

Center Headcount (less Students and Data Specialists) divided by ratio number = demand slots (rounded up or down to the nearest whole number)

Example:

250 employees in center headcount divided by 70 = 3.5 = 4 demand slots

230 employees in center headcount divided by 70 = 3,2 = 3 demand slots

Allotment of PPD/Demand Slots by Week Day

Mondays will have one demand slot for every 70 people in the center headcount, excluding New Hire classes: 1:70.

Tuesdays through Fridays will have one demand slots per 40 reps
